WIPLA's first 2013 program: Mentoring panel meets enthusiastic audience

The January program, entitled "Mentoring Up and Down: What I Wish I Knew Then, What I Need to Know Now" featured a panel of attorneys from both corporations and law firms, including Norma Formanek of Trilliant, Mary Huser of Bingham McCutcheon, Joie Le of Samsung, Katie Scott of Dickstein Shapiro, and Yuridia Caire of Kramer Levin. Lisa Kobialka of Kramer Levin moderated the panel. The event was hosted by Kramer Levin, and provided one hour of MCLE credit.

The panel spoke frankly to the audience of over thirty attorneys about key factors in career navigation. They stressed the importance of *asking*: asking for help, feedback, recognition and work. Ms. Le said that women need to develop a "thick skin" when receiving feedback without being overly sensitive to negative comments. Ms. Formanek noted that feedback can not only improve performance, but prepare attorneys for reviews.



Panel members repeatedly mentioned how helping other women is a source of satisfaction and inspiration in their careers.
